The Toxic-Free Legacy program works to secure precedent-setting policies in Washington State to phase out toxic chemicals used in products and advance safer solutions. TFF conducts research, publishes educational materials for the public and government officials, and promotes policies to achieve its goals.

4b (Code:) (Expenses \$ 663,456 including grants of \$ 349,260) (Revenue \$ 11,500)

Safer States is a coalition of state environmental health organizations working to advance government and corporate policies to phase out the use of toxic chemicals in products. Safer States strategically aligns state, local, market and federal initiatives into coordinated campaigns and provides networking, planning, capacity, and communications support to participating organizations.

The Mind the Store program is transforming the safety of retail consumer products, packaging, and global supply chains by challenging retailers to develop comprehensive safer chemicals policies to phase out harmful classes of toxic chemicals. Its central tool is the annual "Who's Minding the Store?" report card, which ranks the biggest U.S. retailers and recommends action for improvement.

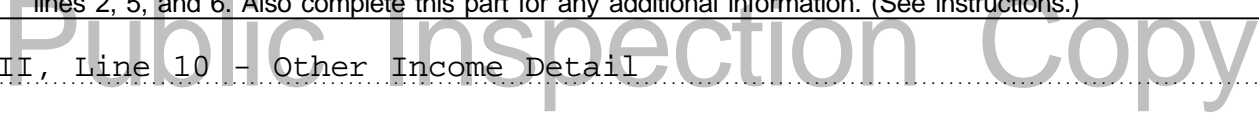

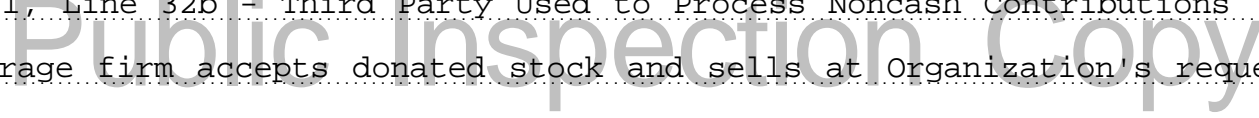
